ABC WP 2020 & 2021	12 PDUs for 2 years, comprising 10 structured PDUs and 2 unstructured PDUs	5 Structured PDUs will be waived for renewal between January 2020 & December 2021. This is equivalent to 1 year of the required structured PDU or 50% of the required structured PDU for 2 years.

REs and RTOs in M&E 2020/2021	6 STUs annually	50% waiver for one year, i.e. 3 STUs are required for renewal that is coming up between July 2020 to June 2021. Waiver is made in consultation with ACES. STU already clocked or carried forward from the previous year can be used for 2021/2022 renewal.

We hope that the above adjustments will help in alleviating your burden during this period. Meanwhile, we encourage you to take this opportunity to work on your continuing professional development.
